The Revenue collection by MMSD into the Federation Account for the month of **January 2023** was **₦ 806,098,677.37**. We recorded a decrease in Royalty collection for the month by - **₦ 888,367,775.86** when compared with the previous month. The decrease in royalty is attributable to the following:

- The Mining activities has just resumed for the year and mining operations are gradually returning to full capacity.

Furthermore, there is also a decrease in the month of **January 2023** for Fee collection from Mining Cadastral Office (MCO) when compared with the previous month by - **₦ 83,783,750.00** due to:

- Gradual payment of Annual Service Fees for the year 2023 which has just resumed.

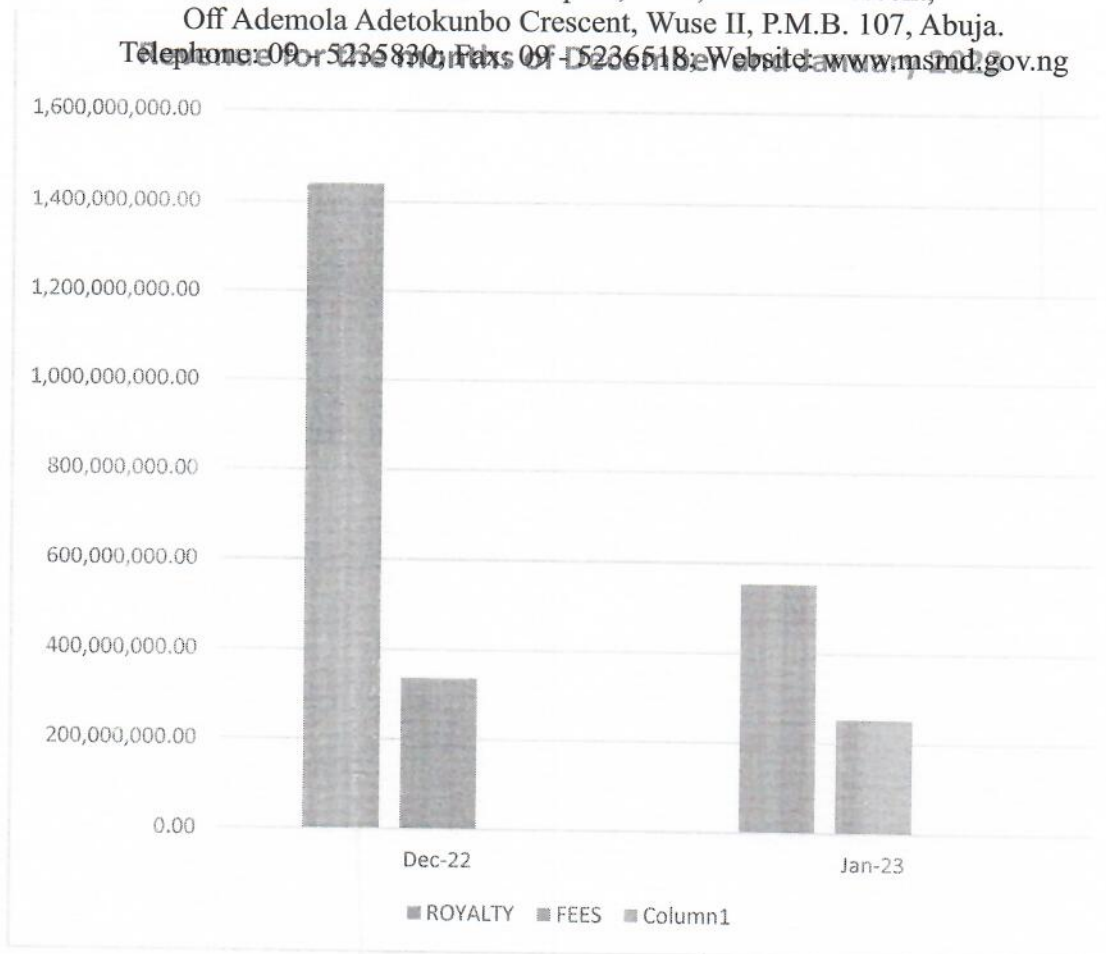
3.Graphic Illustration of Revenue Collection for December 2022 and January 2023.
