**The Report on Taxes Collected by FIRS for the Month of February, 2024 to the FAAC Meeting Holding on 21<sup>st</sup> March, 2024.**

## 1.0 INTRODUCTION

On behalf of the Executive Chairman of Federal Inland Revenue Service, I am delighted to present to the Federation Account Allocation Committee details of the performances of the scheduled taxes of the Service for the month of February, 2024 as attached in Appendices I – IIIA, B & C, and summarized below:

Note: The service is expecting a total of N 1,211.782billion from NNPC being the cumulative PSC PPT and JV PPT and gas income payment for the period June, 2023 to February, 2024 which hitherto was used as FIRS share of Federally funded project.

**1.0 OIL TAXES (PPT/HT & CIT ON UPSTREAM ACTIVITIES):**

The Oil Taxes collection for the month of February, 2024 was ₦763.118billion. This performance is higher than January 2024 collection of ₦325.064billion by ₦438.054billion representing a 134.76% increase. It is lower than the 2024 monthly target of ₦829,967billion by ₦66,849billion (i.e., 8.05% shortfall). The reason for the increase in the PPT collections when compared with previous month is due to increase in receipt of CIT on Upstream Activities.

**2.0 COMPANIES INCOME TAX & OTHERS (CIT, WHI, CGT & SDD)**

The CIT & other taxes collection for February, 2024 amounted to ₦252.398billion. When compared with the 2024 monthly target of ₦377.251billion, it shows a negative variance of ₦124.853billion or 33.10% shortfall. This represents a performance level of 66.90% to the target. It is lower than the previous month's collection of ₦513.100billion by ₦260.702billion or 50.81%. The decrease in performance is as a result of decrease in CIT & other tax payments received for the month.

**3.0 VALUE ADDED TAX (VAT)**

The Total VAT collection for the month of February, 2024 amounted to ₦460.488billion. When compared with the 2024 monthly target of ₦329.510billion it translates into a performance level of 139.75%. It is higher than the ₦420.733billion collected last month by ₦39.755billion or 9.45%. The increase in the collection for the month relative to the preceding month was due to increase in the consumption of VAT-able goods.

**4.0 ELECTRONIC MONEY TRANSFER LEVY (EMTL)**

The collection for February, 2024 amounted to ₦15.788billion and this is reported in our collection for the month.

**5.0 TOTAL COLLECTED INTO FEDERATION AND VAT POOL ACCOUNTS**

The total amount collected for Federation, VAT and EMTL in February, 2024 is ₦1,491.792billion. This performance is lower than the 2024 monthly target of ₦1,551.321billion by ₦59.529billion or 3.84% and a performance level of 96.16%. It is higher than the amount of ₦1,275.481billion collected in January by ₦216.311billion or 16.96%.

When all the tax types above are compared to the total collection of ₦1,491.792billion; Oil Taxes collection of ₦763.118billion represents 51.15%, CIT & other taxes collection of ₦252.398billion represents 16.92%, VAT collection of ₦460.488billion represents 30.87% while EMTL collection of ₦15.788billion represents 1.06%.

Note: The exchange rate used is the CBN mandated exchange rate of USD 1543.5810, EURO 1674.1680 and £1954.7910
