Report on Revenue Collected by the Ministry of Solid Mineral Development for the month of March, 2024 presented to the Federation Accounts Allocation Committee (FAAC) meeting holding on the 19th April, 2024.

On behalf of the Honourable Minister, Ministry of Solid Minerals Development, I present the report of revenue collected in the month of March, 2024 for your kind consideration and adoption.

2. Note:

- The Revenue collection by MSMD into the Federation account for the month of March, 2024 is **N1,723,003,663.28**. The Ministry recorded a positive variance of **N997,482,328.27** from Royalty collection, for the month under review when it is compared with the previous month's collection.
- The total sum of **N818,816,411.28**, positive variance was achieved when you compare the monthly collection against the monthly target, representing 92% positive variance.
- Furthermore, there is also a negative variance of – **N20,641,800.00** for Fees collected from Mining Cadastral Office (MCO) when compared with the previous month of February, 2024 collection.

However, the positive variance could be attributable of the following:

- Collaborative efforts of the Ministry with the stakeholders in the sector. The Ministry has inaugurated the Mine Rangers as an internal security outfit helping to stem the tide of insecurity in most mining areas.
- Improvement of Mining activities in most of the states including FCT.


