REPORT OF THE REVENUE COLLECTED BY THE NIGERIA CUSTOMS SERVICE TO FEDERATION ACCOUNTS ALLOCATION COMMITTEE (FAAC) HYBRID MEETING HOLDING AT THE AUDITORIUM, FEDERAL MINISTRY OF FINANCE, ABUJA ON 15TH DECEMBER, 2022

On behalf of the Comptroller-General of Customs, it is my pleasure presenting to you this report on revenue collected by the Nigeria Customs Service (NCS) for the month of **NOVEMBER**, **2022**.

The Service collected the sum of N135,631,679,220.41 as detailed below:-

The collection of \$135,631,679,220.41 in the month of NOVEMBER, 2022 accounts for 80.62% of the 2022 monthly budget of \$168,244,961,980.83 (Appendix ``A''). However, this is higher than NOVEMBER, 2022 collection of \$133,086,695,390.34 by \$2,544,983,830.07 or 1.91%. This is attributable to increase in the volume of Imports in the month under review relative to the preceding month.

The transfer to the Federation Account by the CBN for the month amounted to \$142,932,958,286.33 (see Appendix \$B''), reconciliation statement (Appendix \$C'') and FAAC revenue reporting format (Appendix \$D'') respectively.
