**REPORT OF THE REVENUE COLLECTED BY THE NIGERIA CUSTOMS SERVICE TO
FEDERATION ACCOUNTS ALLOCATION COMMITTEE (FAAC) HYBRID MEETING
HOLDING AT THE AUDITORIUM, FEDERAL MINISTRY OF FINANCE, ABUJA
ON THE 19th AND 20th OF SEPTEMBER 2023**

On behalf of the Comptroller-General of Customs, it is my pleasure presenting to you this report on revenue collected by the Nigeria Customs Service (NCS) for the month of **AUGUST 2023**.

The Service collected the sum of **₦226,639,955,927.86** as detailed below: -

The collection of ₦226,639,955,927.86 in the month of AUGUST 2023 accounts for 109.3% of the 2023 monthly budget of ₦207,366,848,384.75 (Appendix "A"). However, this is higher than JULY 2023 collection of ₦200,087,003,146.89 by ₦26,552,952,781.00 or 13.27%. This is attributable to increase in the volume of Import duty, Excise, Fees and CET Levies in the month under review relative to the preceding month.

The transfer to the Federation Account by the CBN for the month amounted to ₦226,639,955,927.86 (see Appendix "B"), reconciliation statement (Appendix "C") and FAAC revenue reporting format (Appendix "D") respectively.




