**REPORT OF THE REVENUE COLLECTED BY THE NIGERIA CUSTOMS SERVICE TO  
FEDERATION ACCOUNTS ALLOCATION COMMITTEE (FAAC) HYBRID MEETING  
HOLDING AT THE AUDITORIUM, FEDERAL MINISTRY OF FINANCE, ABUJA  
ON THE 19<sup>th</sup> OF APRIL, 2024**

On behalf of the Comptroller-General of Customs, it is my pleasure to present to you this report on revenue collected by the Nigeria Customs Service (NCS) for the month of **MARCH 2024**.

The Service collected the sum of **₦298,421,221,305.41** as detailed below: -

The collection of ₦298,421,221,305.41 in the month of March 2024 accounts for 113.07% of the 2024 monthly budget of ₦263,918,993,344.54 (Appendix "A"). However, this is higher than the February 2024 collection of ₦254,461,273,306.39 by ₦43,959,947,999.02 or 17.28%. This is attributable to the increase in the volume of Import Duty in the month under review relative to the preceding month.

The transfer to the Federation Account by the CBN for the month amounted to ₦298,421,221,305.41 (see Appendix "B"), reconciliation statement (Appendix "C"), and FAAC revenue reporting format (Appendix "D") respectively.
