REPORT OF DECEMBER 2023 REVENUE COLLECTION PRESENTED AT THE FEDERATION ACCOUNT ALLOCATION COMMITTEE (FAAC) MEETING HELD ON 23RD JANUARY 2024

This report represents a summary of Royalties (Oil & Gas), Gas Flared Penalty, Rents and Miscellaneous Oil Revenue (Licenses and Permits) collected by the Nigerian Upstream Petroleum Regulatory Commission (NUPRC) and remitted to the Federation Account in December 2023 as statutorily mandated.

2. Please find below the table showing the summary of Revenue Performance for the month:

3. The sum of **N233,804,688,683.41** was collected in December 2023. When compared with **N363,547,656,529.32** in November 2023, total collection decreased by **N129,742,967,845.91** equivalent to **35.69%** (See Appendix i for details).
4. Also, there is a negative variance of **N68,813,921,274.67** equivalent to **22.74%** when compared with the 2023 total approved monthly budget of **N302,618,609,958.08** (See Appendix i for details).
5. The amount transferred to the Federation Account for the month of December 2023 was **N233,804,688,683.41** (See Appendix iii) while the total actual amount transferred to the Federation Account by CBN from January to December is **N2,446,351,732,278.14** (See Appendix iii for details).
6. Please note that the Commission's performance from January to December 2023 is **N3,825,193,939,003.44**. This is inclusive of NNPC JV Royalty Receivable of **N1,378,842,206,725.30** for the period of January to November 2023. When compared with the approved revenue collection budget of **N3,631,423,319,496.90** for year 2023, the Commission's performance surpassed the approved budget with **N193,770,619,506.54** equivalent to **5.33%**. Therefore, the overall percentage performance for 2023 is 105.33% and this is exclusive of NNPC Ltd December 2023 JV Royalty Receivable which can only be accessed after FAAC Meeting.
7. Furthermore, we confirm receipt of **US\$57,654,714.15** in the month under review from the cumulative outstanding amount of **US\$1,232,522,530.61** expected from PSC, DSDP, RA and MCA liftings leaving a balance of **US\$1,174,867,816.46** (See Appendix iv). Kindly note that the Commission has written severally to NNPC Ltd to demand for these unpaid statutory obligations and the engagement is still ongoing to ensure early close out.
8. In addition, NUPRC total receivable from NNPC Ltd JV Royalty from October 2022 to November 2023 amounts to **N1,571,691,258,150.88** (See Appendix v).
9. The balance on the Ledger Account of the divested Forcados Assets Good and Valuable Consideration (GVC) as at 4th March 2022 was **US\$599,813,170.02**. The Commission has so far collected a total sum of **US\$499,388,525.00** leaving a balance of **US\$100,424,645.02** as at 11th January 2024. For ease of reference, please find attached the Ledger on this Revenue Item.
