The sum of N158,382,810,624.33 was collected in September 2021. When compared to N120,436,754,684.41 in August 2021, total collection rose by N37,946,055,939.92 or 31.51% in September 2021. (See Appendix I for details).

Also, the revenue for the month represents a positive variance of N1,736,710,275.75 or 1.11%, when compared to the 2021 estimated monthly budget of N156,646,100,348.58. (See Appendix I for details).

The amount transferred to the Federation Account for the month was N158,382,810,624.33 (See Appendix III).

Please note that the Commission's year to date contribution to the Federation Account is N1,516,625,326,868.23 (See Appendix III for details).

Furthermore, we confirmed receipt of a sum of US\$236,855,393.08 from the US\$521,186,525.22 expected from PSC, RA and MCA liftings for the month under review; leaving US\$289,350,209.42 as outstanding (See Appendix IV).

In addition, no sum was paid into the Zenith UK Bank Account for Good and Valuable Consideration in September 2021 and the balance on this account is nil.
